The PARID Board worked with the RID bylaws committee to draft the revision that was sent to the membership. This new structure will allow PAIRD to work together with all of the dis-

For the first time, PARID has collaborated with PaTTAN to offer the EIPA performance exams during our 2009 conference. This collaboration was a great success. 

Motions Passed by the PARID Board on November 1, 2008

Motion # 2008 – 25. To approve the board meeting minutes from August 9, 2008 as read. Rationale: Procedural in nature. Fiscal Impact: \$0.00. N. Wade / M. Hardway. Motion carried.

Motion # 2008 – 26. To approve the mission statement and description for the Public Policy Committee Description. Rationale: This document will help in the standardizing of PARID's documents as well as having policies and procedures in place so that when situations arise the board has a plan to follow. Fiscal Impact: \$0. J. Knoche / N. Wade. Motion Carried.

Motion # 2008 – 27. That PARID purchase 10 Walkie Talkies. Rationale: These walkie talkies will be invaluable during conferences and other events for the event coordinator to keep in touch with the individuals who are assisting. Legislative Report

Provisional Registration

There are currently 2 bills in the state legislature, Senate Bill 642 PN 697 (SB 642) and House Bill 916 PN 1040 (HB 916), to amend Act 57 of 2004 in regards to provisional registration. Both of these bills prose the same changes. These changes are the same as what was proposed last year in HB 1596 PN 3574. Each bill needs to be referred to several committees and have a first, second, and third consideration on the floor of the Senate or House of Representatives before a vote can be taken. Below is the status of each bill. Contact your senator and representative to let them know if you support these bills. The legislative website is www.legis.state.pa.us.

SB 642 PN 697 was referred to the Consumer Protection and Professional Licensure Committee on March 19th. SB 642 was reported back to the Senate floor as committed on March 31st. The first consideration for SB 642 was on March 31st.

HB 916 PN 1040 was referred to the Professional Licensure Committee on March 13th. No other action has been taken to this date.

Testing News from Bloomsburg University

There is some great news coming out of Bloomsburg University. The Bloomsburg University Testing Services has been approved as a CASTLE WorldWide testing administration site. This means that the National Interpreter Certification written exam is now being offered at Bloomsburg University!

First you must send in your application and payment to RID. When you send in your application to RID for the NIC Knowledge Computer-Based Test, your information is then e-mailed to CASTLE WorldWide. They will contact you via e-mail with instructions on how to select a test date and location from their online registration.

After you receive notice from CASTLE WorldWide, you must register through CASTLE's website: www.castleworldwide.com. Click on "Candidates" and create an account. Then sign up for available testing dates that are found within the software. There are only 2 computers available for the test; this means the tests are limited to two candidates at a time. As of now Bloomsburg University is <u>not</u> offering any other exams. But, we are happy to announce offering the NIC written exam. Best of luck taking it and moving one step closer to your ultimate goal of national certification!

CASTLE WorldWide also has testing sites in the Philadelphia, Harrisburg, and Pittsburgh areas. A complete listing of exam sites can be found on the RID website.

New Report on the Situation of Deaf People

The World Federation of the Deaf (WFD) and the Swedish National Association of the Deaf (SDR) released a report "Deaf people and Human rights" written by Ms Hilde Haualand, Researcher, and Mr. Colin All en, Project Coordinator of the Global Education Pre-Planning Project on the Human Rights of Deaf People. The "Deaf People and Human Rights" report is based on a survey that is, up until now, the largest knowledge database on the situation of Deaf people. The lives of Deaf people in 93 countries, most of which are developing countries, is addressed. The Swedish National Association of the Deaf and the World Federation of the Deaf initiated the survey, with funding from the Swedish Agency for International Development Cooperation (Sida) and the Swedish Organisations of Disabled Persons International Aid Association (Shia). In the coming weeks, the report will also be presented in International Sign on DVD and on WFD website.

Conference on legal interpreting

26 – 29 November, Antwerp, Belgium

For some time now the EU Commission DG Justice, Freedom and Security has felt the need to be able to consult a representative body of the legal interpreters and translators in the EU. Other legal professionals such as public prosecutors, lawyers, judges or police officers, all have their EU associations and can be heard on matters that are of interest or concern to them or the European Commission. The legal interpreters and translators, as yet, do not have such a representative platform in the EU. That is why a consortium of academic and professional organisations has proposed the establishment of EULITA, an international non-profit European Legal Interpreters and Translators Association. To mark the launching of EULITA and reflect on the opportunities and challenges before us in the field of legal interpreting and translation, a three -day conference is held on 'Aspects of Legal Interpreting and Translation', Antwerp (26 -29 November 2009). On the first day of the conference, the aims and Articles of Association of EULITA will be presented and discussed by representatives of national or regional associations, followed by the official launch of the association which is open to all conference participants.
