President's Report Cindi Brown, CI, CT

Winter weather has finally arrived in Pennsylvania. Take a few minutes to sit by the fire and read this issue of the PARID News. This issue is full of updates, activities, and the business of the organization. Two of these items are mentioned in my brief report.

First, The local chapter to sub-committee transition is continuing. I will send letters to the districts explaining the process and timeline for

transferring the funds to PARID's account. If everything goes as planned, all of the funds should be in PARID's account by the end of February. Using the feedback that was collected in 2007, the board has approved a policy and procedure for the disbursement of funds.

Second, and most important, it is time for nominations for half of the board positions. Each board member has written a brief description of their job. Read these articles, then contact the board members with your questions, finally submit your nomination to the board for each position. See page 6 for details on nomination and election requirements and time lines.

Call For Support Mark Hardway

During tough economic times, non-profits and professional organizations relying on volunteers to serve their membership tend to suffer from a lack of support. This article is a call for support for your own professional organization. We have published articles to illustrate the value added by having an affiliate chapter of RID in our state by showing specific ways that opportunities are afforded to the members in the state.

Perhaps the best way to illustrate the value of having an affiliate chapter is to imagine what it would be like if we did NOT have an affiliate chapter. If there is no affiliate chapter, then there is no official body to sponsor workshop opportunities throughout the state. Traveling to other states to learn and earn CEUs would be a large inconvenience to our membership. We have a very active and successful SWAP program operated as a part of our affiliate chapter, allowing members to have the opportunities to earn CEUs on their own time through the lending of training CDs. This valuable opportunity would disappear without the affiliate chapter.

With no affiliate chapter, there would be no central means of communicating with our state's membership regarding issues important to the state. There would be no means of emailing or mailing to our state's members directly. We would not have a website listing local workshop opportunities or giving updates on legislation impacting us within our state. We would not have representatives from the Board of Directors to appear at the state capital to lobby for our profession's concerns and influence the establishment of laws and regulations impacting interpreting. Nor would we have liaisons with ODHH or PSAD to coordinate our profession's general interaction with the deaf and hard-of-hearing communities within the state.

Our affiliate chapter also does some things that go above and beyond what some other chapters may do. A prime exam-



ple is the certification testing opportunities that PARID has been setting up for individuals within our state. It is no small task to coordinate and offer such one-time testing sites within our own state. We are unaware of any other affiliate chapter who is making this effort to help advance the careers of its membership. Again, this disappears without an active affiliate chapter.

I reference this scenario of the affiliate chapter disappearing, because we recently had an affiliate chapter in a neighboring state that was forced to dissolve and another one that became inactive. We have a large number of interpreters within our state, most of whom are very qualified to serve the chapter in a more direct way. We are publishing descriptions of the District Representative positions, as well as the other positions on the Board of Directors. We can really use more people to step forward and devote about 2 years to serving the organization. As you will see when reviewing the descriptions, the roles involve spending a day at Board meetings 3-4 times each year at various locations around the state, along with some other specific responsibilities that go along with each position. Most of these are seasonal in nature and do not "consume" the participants on a daily basis.

We currently have several board positions that are vacant or being vacated within the next year or so. There are also several districts with NO representative on the Board. Please consider spending a little bit of time and giving back to your profession. We would really like to see some of the interpreters who are newer to the profession get involved. It is a great way to enhance your career, as well as the careers of those around you. Also, don't feel shy about nominating yourself for a position! If you feel you may want to serve in some capacity, please contact our President, or any other Board Member to discuss how you might best assist the organization based on your talents, abilities, and background. Don't feel you need to have extensive qualifications and experience to serve! (I have been on the Board for 2 years, and am just an Associate Member who is currently only interpreting in the religious arena.)

Our goal is to have MANY people involved, with each one doing a LITTLE to help. In speaking with other Board Members, the primary frustration is from the lack of people getting involved, NOT any frustration over the job responsibility itself being difficult. The call to serve goes well beyond just the Board positions. You play a key role in serving by marking your calendar and attending any meetings held by your District Representative. Having limited involvement at the district level leads to limited involvement at the state level, and can ultimately lead to the affiliate chapter dissolving. Please help us to keep PARID alive and continuing well into the future!

Position Descriptions

President Position Description Cindi Brown (president@parid.org)

My term as President ends this coming year. Due to the term limits in our bylaws, I am unable to run for President and will become the Immediate Past President. This newly created position will allow me to remain on the board for two more years in an advisory position to support the newly elected President. I have divided the President's responsibilities into two main categories, responsibilities to PARID and responsibilities to RID.

Responsibilities to PARID:

Generally, the President oversees the general business of the organization, presides at all meetings (4 board meetings and 1 membership meeting per year), and represents PARID. More specifically, the President drafts meeting agendas, appoints committees, co-signs checks, writes newsletter articles, communicates with the membership via the newsletter and email updates, and responds to questions from the membership, hearing individuals, deaf individuals, students, and others.

Responsibilities to RID:

The President works with the Region I Representative and fellow Region I Presidents on issues affecting the region. The

Region I Presidents' Yahoo Group allows all of the Region I Presidents to easily communicate and share ideas. We also have 2-hour conference calls every 2-3 months. The President is also a member of the RID Affiliate Chapter Presidents' Yahoo Group. Here you have the opportunity to discuss and share ideas with all of the other affiliate chapter presidents in the country. The President also drafts and submits PARID's annual report to RID.

The position of President does take more time than the other positions and the list of duties can seem long. The key to success in this position is keeping up with things as they occur. I spend an average of 5-10 hours per week on PARID/RID business. Most of this time is spent reading emails and responding to questions. With a good team of board members and an active membership to assist, it is a manageable task. I look forward to working with the newly elected President to continue the good work of PARID. Take this opportunity to get involved and make a difference!

Vice President Position Description Cindi Brown (president@parid.org)

The Vice President assists the president in performing his/her duties. In the absence or disability of the President, the Vice President performs the duties of the President. The Vice President also works with the district representatives to assist with scheduling and coordinating professional development activities. The Vice President keeps in contact with the board members through the PARID Board Yahoo Group. This position is currently vacant. If you are interested in participating immediately as the Vice President, send an email to president@parid.org.

Recording Secretary Jessica Bentley-Sassaman (recorder@parid.org)

The Recording Secretary position will be up for election this May. My experience with this position has been a positive one and I would like to take the opportunity to explain my duties. The PARID Board meets four times a year. Approximately two weeks before the meeting the Board members post their reports to the PARID Yahoo Group page. As recording secretary I am responsible for collecting reports for the PARID meeting. This means going into the Yahoo Group to retrieve reports to copy and paste them to the meeting minutes. I am also responsible for contacting ODHH and PSAD to get reports from both of them. I do have to email ODHH and PSAD about three weeks before the reports are due. The reason being is that we have to supply the interpreters the meeting minutes one week before the Board meeting.

All of this work does not take much time at all to copy and paste reports and to send out emails to remind ODHH and PSAD to send me a report. I would say that collecting and making the meeting minutes takes me no more than two hours total of my time. Those two hours are spread out over three weeks.

During the meetings I follow the meeting minutes and make corrections where necessary. I am also in charge of typing up the motions, action items, new business, and then proof reading the minutes before I send it on to the president for review.

As a Board member I am also responsible to be involved in PARID discussions that take place in between meetings via our Yahoo Group. These discussions typically do not take long to answer. I would say that answering the discussions on the Yahoo Group – which are sent directly to your email, takes me about 10 - 20 hours a year.

I do attend the four Board meetings a year. If I cannot make it, I am responsible to find a proxy to take the meeting minutes for me. Often another Board member is willing to do it. If I cannot attend a meeting, I do make every effort to call in on that day.

All together I spend 8 hours per Board meeting (32 hours total), 8 hours per year preparing for the Board meeting, and 10-20 hours a year answering email. This makes a grand total of 50-60 hours a year. Consider giving back to PARID for all the services that are offered to our members such as testing opportunities, programs, and conferences.

Treasurer Position Description Mark Hardway (treasurer@parid.org)

Following is a summary of primary responsibilities for the PARID Treasurer:

- 1. Make all deposits to PARID bank accounts throughout the year. (The primary times for major deposit activity are springtime processing of conference registrations, and the June/July processing of annual membership renewal checks.)
- 2. Disburse checks as needed for PARID expenses throughout the year.
- 3. Maintain the PARID checkbook register as well as the Excel workbook for managing all PARID bank accounts and categories for income and expense. This workbook includes tracking the expenses, income, and funds available to each district within PARID.
- 4. Every January, prepare 1099-MISC forms to be sent to any contractors who were paid more than \$600 in the previous calendar year. (The corresponding summary report to the IRS must be filed by the end of February.)
- 5. Prepare a quarterly financial report to bring to the Board of Directors, and to publish in the newsletter. These reports are created automatically from the Excel Workbook.
- 6. Attend the Board of Directors meetings 3-4 times per year, and be ready to disburse checks as needed at these meetings.
- 7. Within 3 months after the end of the fiscal year (by Sept 30), prepare a year-end financial report to be filed with RID, and to be filed as IRS Form 990. This is easily created from the Excel Workbook.

Corresponding Secretary Position Description Annie Hardway (membership@parid.org)

Following is a summary of primary responsibilities for the PARID Corresponding Secretary:

- 1. Receive all membership renewals and input them into the Access database for membership. (This activity is primarily in the June/July timeframe each year.)
- 2. Prepare and distribute receipts and PARID Membership Cards to each renewing or enrolling member.
- 3. Prepare summary reports of total membership by District, and forward with each batch of renewal checks to the Treasurer for deposit.
- 4. Communicate with individual members and the Board of Directors regarding any issues with an individual's membership.
- 5. Prepare summary reports and membership rosters for each District Representative.
- 6. Send out any official correspondence from PARID throughout the year.
- 7. Attend the Board of Directors meetings 3-4 times per year.
- 8. On at least an annual basis, prepare a demographics report for the Board of Directors and the general membership.

What does a District Representative Do? Rich Wilson, Allison Carr, and Sandy Shaika district2rep@parid.org, district5rep@parid.org, district7rep@parid.org)

Calling all potential District Reps out there! That's right, we see you. Who me? You may be asking yourself, what does a district representative do? We're happy you asked.

There are currently five districts without a representative (1, 3, 4, 6, and 8). Due to the nature of how members pay dues, each of these districts has funds available for workshops. One of the duties of a district representative is to oversee workshops in your district. Oversee does not mean plan alone. Work is much less daunting and frankly more fun when done together. A district representative also holds meetings in their respective districts to gain input from members and to plan workshops together. That sums up the local duties. For the PARID Board, a district representative attends four meetings a year. The representative also writes a short report for each board meeting as well as a newsletter update four times a year.

Not too bad, right? PARID thrives when the board can function fully. Please consider helping not only your local district but also your state board. Give it a try. We'll all be here to help.

Prognosis Excellent: Medical Interpreting at Your Best

As an interpreter, you are well trained and prepared for the task. Your duties are clear in a generic sense. However, as you step into other professionals' arenas and the duties are compounded by the context of each setting, it is helpful to know the expectations for our work of and by these professionals. This understanding will enable us to be more effective and for our work to seamlessly coexist within the context of the setting to the greatest extent possible. This workshop will explore the duties of an interpreter in medical settings from the perspective of a medical professional who is also an interpreter.

American Deaf Culture

An overview of characteristics of cultures will be provided as well as its applications to Deaf culture. The RID CMP process is not as complicated as it may seem at first. With a little bit of explanation you can easily earn your required CEUs. As CMP coordinators for PARID, we are here to answer your questions and assist you through the process of earning CEUs. This column is one of the ways that we will be providing you the information you need. If you have a CMP topic that you would like to see addressed in this column, send it to cmp@parid.org.

Ouestion:

What are the different ways to earn CEUs to fulfill the cycle requirements?

Answer:

There are four avenues you can utilize to accrue CEUs for your transcript.

- *One option is to attend a workshop that is hosted by an RID approved sponsor. This would include workshops, conferences and silent weekends.
- *Another option available to attain CEUs is to attend a workshop or conference not sponsored by an RID approved sponsor. For this Participant Initiated Non RID Activity (PINRA), submit the complete PINRA form to CMP Coordinator, Lynette Jones, prior to the event.

If you would like to host a workshop or are in need of PINRA forms or additional information to complete the PINRA process or host a sponsored workshop, contact Lynette Jones (cmp@parid.org) or via postal delivery.

*Yet another option is to do academic coursework. This format is designed for individuals taking a class from an accredited institution of higher learning and receiving a passing grade of "C" or better. The academic coursework must be completed during the CMP cycle to which you want to apply it.

*The final opportunity to earn CEUs is to complete an independent study activity. Examples of this activity may include a home study with videos, research or literature review, study group, acting as a mentor or mentee, curriculum/workshop development, or teaching a workshop for the first time. For this classification, you must submit a specific plan with objectives and dates of projected fulfillment. Supporting documentation must be provided throughout the process to meet requirements as set by the CMP Coordinator.

Members of the SC/BRTF are currently in the process of gathering member feedback and opinion related to the organization and governance of YOUR professional association. For those of you who may be unfamiliar with the task force, the SC/BRTF was established in 2008 to conduct a thorough review of Motions E-S from the 2007 business meeting, research the impact to the association bylaws and other governing documents and to make recommendations to the board on potential changes to membership categories, credential definitions and voting privilege categories. The SC/BRTF was also asked to develop a proposed organizational structure that clarifies the membership categories, voting rights and defines credentials for RID Certified, NAD Certified, EIPA Certified, Associate, Student, Senior Citizen and other affected members of RID.

The task force has worked together to formulate some initial thoughts and recommendations to the board and then shared those ideas with you, the membership, at various regional forums and requested your feedback. We've incorporated all of your helpful comments into a new set of concepts for you to consider, and we are now again asking for your help.

Some of you have already seen the new concepts if you attended our forum at the 2009 RID National Conference in Philadelphia. These concepts have been posted to SC/BRTF's Web page on the RID Web site for all members to view, discuss and send comments or suggestions. As the task force is working on behalf of the membership at large, we'd like as much membership feedback as possible before we make our final recommendation to the board by 2011.

Legal Interpreting in Pennsylvania

As you may or may not know, there was a law passed in 2006, called Act 172, which requires anyone who interprets for legal or judicial procedures such as: Police stations, District Magistrates, District Justice offices, Court cases, Worker's Compensation Hearings, Unemployment Compensation Hearings, Domestic Relations, Probation meetings/hearing, etc., or anything that is adjudicated by the State of Pennsylvania to be interpreted by a "Certified" or "Qualified" Interpreter as deemed by the Administrative Office of Pennsylvania Courts (AOPC) and follow their rating system. The AOPC has its own "certification" process (not to be confused with the RID SC: L). The AOPC has a "certification/qualification" process that governs any variety of spoken language interpreters AND sign language interpreters working in legal settings. Even those sign language interpreters who have

been interpreting in court/legal situations for years need to go through the AOPC process before being added to the list of interpreters that can be used in legal situations.

It has been a blessing to attend several RID workshops over the years, by Carla Mathers, Denise Brown, Tara Potterveld, Eve West, and many others, and to attend several weekend workshops offered by the Widener University Law Center, learning from many other individuals and organizations with tons of experience in working with interpreters in the legal arena. I have also done many observations of working legal interpreters and legal proceedings. It has always been interesting to me but I was afraid to take the leap even after 5 years of workshops and observations!!! I did attend the AOPC Orientation (only offered at select times of the year) and have passed the written test (only offered at select times of the year) with flying colors.

Interestingly enough, one of the first places a spoken language interpreter works is in the court system, because that is where they are supposedly first able to get paid for their work. It is quite the opposite for a sign language interpreter, as we tend to go into the legal field WELL after having training and experience under our belts. Before we even ATTEMPT the legal arena, we work in educational situations, regular medical appointments, emergency room/trauma situations, government meetings, board meetings, job trainings, business meetings, theater/stage, and conferences. Only THEN might we consider Legal Interpreting.

The process for sign language interpreters to get on the AOPC list is a pretty straightforward one. First, you must have the required RID certification (SC: L being the top), and attend an AOPC Orientation (2 full days, with RID CEUs). Next, you need to take a written test (covering vocabulary, ethics, proceedings, etc.). Since certified sign language interpreters have already tested on the "performance" part of the interpreting process, they only need to take the one day AOPC Orientation, pass the written test, a background check (yearly) and pay the required fees to maintain their "certification" status. There are also required CEUs that must be maintained (separate from RID). These do need to be approved in advance for AOPC and do not have to be RID CEUs. You can always apply in advance for PINRA CEUs if it is not an RID-sponsored training. Widener University Law Center has several upcoming weekend workshops presented by Carla Mathers on the topics of "Table Interpreting" held on February 6th and 7th, 2010, and the topic of "Depositions" held on March 6th and 7th, 2010.

For more information on Legal interpreting, visit several websites, such as: www.rid.org (look under Legal Interpreter Member Section), www.courts.state.pa.us/T/AOPC, www.najit.org, and many others. Some states will reciprocate with PA without testing, but still require paying licensure fees.

Come on everyone! We need more of you to step out into the field of Legal interpreting! You can do it!

Just Ask ODHH!

Act 57, PA's interpreter law, took affect in 2005, and this past year ODHH has implemented new policies & procedures to comply with the Act and its regulations. We would like to take the time to review a few items of interest with you.

- § The Sign Language Interpreter & Transliterator State Registration Act, Act 57-2004, was signed into law in 2004 and took affect on July 1, 2005. The act sets a minimum qualification standard for interpreters working in the Commonwealth. It requires interpreters who meet the eligibility requirement to register with ODHH.
- § Eligible certifications for registration are:

CSC MSCS
CI CT
CDI NIC
NIC Advanced NIC N

NIC Advanced NIC Master NAD IV NAD V

- § \$100.00 registration fee is due biennially. Fees will be prorated.
- § With the passing of the regulations, all registrations expire on December 31 of every even numbered year. Registrations will expire on December 31, 2010. The new system will prorate the registration fee to get all registrants on the same cycle.
- § Registrants are notified by email. It is your responsibility to update your profile's contact information to receive the email notifications.
- § To ensure you meet the registration requirements during the 2 year registration period, all registrants are required to submit proof of certification. You will receive an email, which include deadlines, to submit the documentation. For your registration to continue without interruption, Dee Dee must receive the documentation by the deadline; failure to do so will trigger the system to remove your from the registry. When ODHH receives & verifies the documentation your registration status will be restored.
- § Near the end of your CMP cycle, you will be notified by email to submit a copy of your transcript. ODHH must verify that all registrants obtained their 8 CEUs therefore maintaining their certification and registration status.
- § Dee Dee Keiser, lead person working on the registry, is working with our IT department to resolve a few perpetuating bugs. When the system is working properly, Dee Dee will distribute the registration cards.
- § On your profile, please review the counties you selected for work to ensure that they are accurate. Make any necessary changes.
- § Interpreters who are eligible to register, but are not registered, are violating the Act. If you allowed your registration to lapse, did not register within the new system, or are newly certified, please contact Dee Dee Keiser immediately at ra-li-ovr-odhh@state.pa.us or at 717-783-4912 v/tty.
- § The request forms are updated, and are in the process of being posted on our website. These are the ONLY forms non-registered interpreters are permitted to use. Until the forms are posted, contact ODHH for a copy,

- D) As I stated in the beginning, I know that in years past, we have run a "membership business meeting," with a parliamentarian and RRO to boot. I'm changing it up for a few reasons. First, it's what I do. I like to keep things new and exciting and so long as the same goals are accomplished (informative, networking, sense of the membership, etc.), why not play with the design? Secondly, many people run screaming for the hills when the words "Robert's Rules of Order" come up. Or "parliamentarian," for that matter. I want all views represented and this is a way in which everyone can play in the sandbox together, with an equal opportunity to participate. Finally, because whatever comes from our time together is not official or binding, I prefer to see a transparent forum that invites people to listen and be listened to, while understanding that we are focusing on making an impact for our region, and doing so in a way that presents a united voice as a result.

Stay tuned for more information about our Membership Forum. It will be a blast; I look forward to seeing every one of your shining faces there!
