## SWAP Report <br> Tara Potterveld, CI, CT, SC:L

Do you need CEUs? Do you need to develop your interpreting skills? Whether you are a freelance or educational interpreter, you can obtain CEUs and/or new skills while using your computer and PARID's SWAP program. Go to www.PARID.org and open Professional Development. Follow the instructions under SWAP Program to borrow one of 30 different instructional CDs. There is a post test and evaluation on the CD that you must complete and submit to PARID to get the CEUs. Please allow 8 weeks after you return the CD and your paperwork for the CEUs to be registered in your RID account. If you are nearing the end of your CEU cycle, please order the CDs today, to avoid any last minute delays. Below are two of the CDs in the library.

English Equivalents - $\mathbf{3}$ CD set - 18 hours/1.8 CEUs. English Equivalents will assist participants to develop lexical banks or options to vary interpretations in English. English Equivalents in ASL is designed to help students and interpreters confidently manage the flow of information exchange from ASL to English and from English to ASL.Educational Objectives: This workshop will teach techniques to:

- Develop a basic understanding of ASL linguistics in layperson terms
- Develop lexical equivalents to Sign items
- Become aware of idiomatic English usage.

HIPAA and Interpreters: How to do our job under the new rules? - $\mathbf{5}$ hours/ $\mathbf{0} 5$ CEUs. This workshop will discuss the background of HIPAA, its impact on patients and professionals alike, and its role with interpreters in a medical situation. HIPPA and patient privacy is a hot topic these days! Interpreters MAY be considered Business Associates and therefore may be required to have additional responsibility and training. Medical professionals, interpreters, office employees, administrators and patients would all be well-served to have more than a rudimentary knowledge of HIPAA's relatively new regulations. It is also important for the professionals in the medical setting to possess a deeper understanding of the regulations, not only because they are required to conform to them, but because you will one day be a patient yourself.

## President's Position Description Cindi Brown (president@parid.org)

My term as President ends this coming year. Due to the term limits in our bylaws, I am unable to run for President and will become the Immediate Past President. This newly created position will allow me to remain on the board for two more years in an advisory position to support the newly elected President. I have divided the President's responsibilities into two main categories, responsibilities to PARID and responsibilities to RID.

Responsibilities to PARID: Generally, the President oversees the general business of the organization, presides at all meetings ( 4 board meetings and 1 membership meeting per year), and represents PARID. More specifically, the President drafts meeting agendas, appoints com-
mittees, co-signs checks, writes newsletter articles, communicates with the membership via the newsletter and email updates, and responds to questions from the membership, hearing individuals, deaf individuals, students, and others.

Responsibilities to RID: The President works with the Region I Representative and fellow Region I Presidents on issues affecting the region. The Region I Presidents' Yahoo Group allows all of the Region I Presidents to easily communicate and share ideas. We also have 2 -hour conference calls every 2-3 months. The President is also a member of the RID Affiliate Chapter Presidents' Yahoo Group. Here you have the opportunity to discuss and share ideas with all of the other affiliate chapter presidents in the
country. The President also drafts and submits PARID's annual report to RID.

The position of President does take more time than the other positions and the list of duties can seem long. The key to success in this position is keeping up with things as they occur. I spend an average of 5-10 hours per week on PARID/RID business. Most of this time is spent reading emails and responding to questions. With a good team of board members and an active membership to assist, it is a manageable task. I look forward to working with the newly elected President to continue the good work of PARID. Take this opportunity to get involved and make a difference!

## Vice President's Position Description Cindi Brown (president@parid.org)

The Vice President assists the president in performing his/her duties. In the absence or disability of the President, the Vice President performs the duties of the President. The Vice Presi-
dent also works with the district representatives to assist with scheduling and coordinating professional development activities. The Vice President keeps in contact with the board members
through the PARID Board Yahoo Group. This position is currently vacant. If you are interested in participating immediately as the Vice President, send an email to president@parid.org.

## Treasurer's Position Description Mark Hardway (treasurer@parid.org)

Following is a summary of primary responsibilities for the PARID Treasurer:

1. Make all deposits to PARID bank accounts throughout the year. (The primary times for major deposit activity are springtime processing of conference registrations, and the June/July processing of annual membership renewal checks.)
2. Disburse checks as needed for PARID expenses throughout the year.
3. Maintain the PARID checkbook register as well as the Excel workbook for managing all PARID bank accounts and categories for income and expense. This workbook includes tracking the expenses, income, and funds available to each district within PARID.
4. Every January, prepare 1099-MISC forms to be sent to any contractors who were paid more than $\$ 600$ in the previous calendar year. (The corresponding summary report to the IRS must be filed by the end of February.)
5. Prepare a quarterly financial report to bring to the Board of Directors, and to publish in the newsletter. These reports are created automatically from the Excel Workbook.

Corresponding Secretary's Position Description Annie Hardway (membership@parid.org)

Following is a summary of primary responsibilities for the PARID Corresponding Secretary:

1. Receive all membership renewals and input them into the Access database for membership. (This activity is primarily in the June/July timeframe each year.)
2. Prepare and distribute receipts and PARID Membership Cards to each renewing or enrolling member.
3. Prepare summary reports of total membership by District, and forward with each batch of renewal checks to the Treasurer for deposit.
4. Communicate with individual members and the Board of Directors regarding any issues with an individual's membership.
5. Prepare summary reports and membership rosters for each District Representative.
6. Send out any official correspondence from PARID throughout the year.
7. Attend the Board of Directors meetings 3-4 times per year.
8. On at least an annual basis, prepare a demographics report for the Board of Directors and the general membership.

## Recording Secretary's Position Description Jessica Bentley-Sassaman (recorder@parid.org)

The Recording Secretary position will be up for election this May. My experience with this position has been a positive one and I would like to take the opportunity to explain my duties. The PARID Board meets four times a year. Approximately two weeks before the meeting the Board members post their reports to the PARID Yahoo Group page. As recording secretary I am responsible for collecting reports for the PARID meeting. This means going into the Yahoo Group to retrieve reports to copy and paste them to the meeting minutes. I am also responsible for contacting ODHH and PSAD to get reports from both of them. I do have to email ODHH and PSAD about three weeks before the reports are due. The reason being is that we have to supply the interpreters the meeting minutes one week before the Board meeting.

All of this work does not take
much time at all to copy and paste reports and to send out emails to remind ODHH and PSAD to send me a report. I would say that collecting and making the meeting minutes takes me no more than two hours total of my time. Those two hours are spread out over three weeks.

During the meetings I follow the meeting minutes and make corrections where necessary. I am also in charge of typing up the motions, action items, new business, and then proof reading the minutes before I send it on to the president for review.

As a Board member I am also responsible to be involved in PARID discussions that take place in between meetings via our Yahoo Group. These discussions typically do not take long to answer. I would say that answering the discussions on the Yahoo Group - which are sent directly to
your email, takes me about 10 20 hours a year.

I do attend the four Board meetings a year. If I cannot make it, I am responsible to find a proxy to take the meeting minutes for me. Often another Board member is willing to do it. If I cannot attend a meeting, I do make every effort to call in on that day.

All together I spend 8 hours per Board meeting ( 32 hours total), 8 hours per year preparing for the Board meeting, and 10 20 hours a year answering email. This makes a grand total of $50-60$ hours a year. Consider giving back to PARID for all the services that are offered to our members such as testing opportunities, programs, and conferences.


## District 2 Report
