

Mentorship Program

RID states in 2012 an interpreter sitting for the performance test will need a bachelor's degree or have fullfilled the requisites for Alternative Pathway. Be prepared to enhance your professional development.

Recording Secretary's Report Rebecca Friedman, CI/CT

"How are you feeling today?" "Yes."

"Is the patient allergic to any medications?" "No." "Any family history of heart disease?" "No." "Any family history of diabetes?" "No." "And what brings the patient in today?" "No."

That's when I realized that perhaps there was something a little 'off' with this medical appointment. Prior to the physician entering the room, the patient and I had a very brief chat about something innocuous like the weather and based on that very brief chat, I decided ASL was the best mode of communication for this individual. And so we proceeded. After doing what I somewhat arrogantly assumed was 'correct' interpreting, the doctor very smartly asked the patient to repeat back what I had just interpreted. It was a glimmer of a hope of a gist of the message. It was then that I remembered another valuable lesson that I hadn't put into practice in some time. I took that consumer's words and put them to use myself by just saying, "no." This assignment was not working for any of us – the physician, myself and definitely not the Deaf consumer. Ego aside, I had to stop this assignment and did so. I told the physician that based on what I was seeing and the lack of comprehension (which could be due to several factors) I recommended rescheduling and making sure that the office requested a Certified Deaf Interpreter. Thankfully, they complied and another appointment was arranged.

Stopping mid-assignment was not easy, but it was necessary in this situation. And, on a positive note, the opportunity to educate the doctor's office about CDIs presented itself in a very natural way. I also took away a good lesson in assessing an assignment to gauge if it's something I want to accept. Is this assignment a good fit for me? Would all participants (including myself) benefit from my participation? Can I interpret this assignment successfully? And, once in the midst of an assignment, what do I need to make sure that communication is clear between all parties involved? I'm finding the longer I interpret, the better educated I am becoming about my own needs. I know what my limitations are and the skill areas I'd like to improve upon. I know there is help out there (like the mentorship program PARID is starting this September) to improve my skill level and can only work towards becoming the best I can be right now.

It is that time of year again. The annual membership year for PARID ends on June 30. Current members should all have received their forms for renewing their membership. I know it is something that we need to remember to do each and every year, and we often forget because of our busy schedules. This year, we are offering the option to renew for up to 3 years, so you would not need to remember to renew for quite a while.

I would like to give an overview of the process for joining or renewing, which will hopefully answer some of the questions we typically receive. I would also like to address some of the common problems we encounter with completion of the forms.

When you submit your membership materials, they are sent to PARID's central PO Box in Williamsport, PA. Twice each month, the letters received at this box are bundled and shipped to the Membership Secretary for processing. Large batches are processed in the July/August timeframe each year. After entering the memberships into the system, we print out and mail the membership cards to each of the members. The batches of checks are then forwarded to the Treasurer for deposit into the PARID account. This process is why the forms indicate to allow 4-6 weeks processing time.

Filling in the forms COMPLETELY will greatly expedite the processing of the forms. Lines on the form are there for a reason, so it is imperative that you write in all of them. Printing the information clearly and legibly is always helpful. Sometimes important information has been left off the form, requiring more research and work. The county name and district numbers are often left blank. You should know the county in which you live. (If not, then an internet map search will often indicate the county where a particular town lies.) The county will also determine your district. The back side of the form lists the counties included in each of PARID's eight districts. Members from outside of Pennsylvania can just write "out of state" in the county. The email address and phone number are other important items that many people leave off the form. Since the newsletter is automatically sent out electronically, it is very important that we have accurate information for your email.

Late fees are often left off the form, causing additional follow-up. Memberships expire on June 30, but you are actually given a 1-month grace period. Renewals postmarked after July 31 are assessed a \$10 late fee. Memberships postmarked after July 31 will not be processed until the late fee is received. (This does NOT apply to NEW members who join after July 31.) It is also important to you write your check number on the form in the spot for that information.

The bottom part of the form allows us to gather your demographic information. We ask you to check off one PRIMARY job setting, along with one PRIMARY job title. (One special note is that interpreting students should check "Other" for job setting, and write "student," as well as checking "Interpreting Student" under job title... Many students check "Post-Secondary Education" under job setting, which is only for interpreters who work in the college setting.)

We know we have many RID members from PA who have not joined or renewed their affiliate chapter membership in quite some time. We would like to take this opportunity to invite you to join or come back so you can be networked with your professional peers in your area. The membership form is available online at www.parid.org. We look forward to processing everyone's membership cards this year!

Taking Turns

When we were kids, people taught us to "take turns" when playing with special toys or playground equipment. As an adult, I have worked on jobs where employees needed to take turns in sharing on-call responsibilities for handling after-hours situations. Interpreters are probably familiar with situations where attendees of meetings are NOT following the rules of taking turns and speaking out during a meeting. (Does anyone enjoy trying to interpret when five people are speaking at the same time?) When working team jobs, we know how taking turns is especially important. This concept

of taking turns has been a part of every stage of our life.

This article is a request for more of us to take a turn in serving the organization. You can take a turn to serve for 2 vears as a district representative. That responsibility mainly involves keeping members in your district informed of important things in RID or the interpreting community. It is also your chance to inform the PARID Board and RID of events, suggestions, or concerns from membership within your own district. Perhaps you could take a turn serving a 2year term in one of the other

positions on the PARID Board. There are also opportunities to serve on committees or other support functions for PARID.

One of the negative results of us not taking turns in these capacities is a small number of people tend to get burned out by serving not just a 2-year term, but stay on serving for sometimes 6-10 years because there have not been enough people stepping forward to serve in these capacities. The whole organization will reap benefits if more of us will heed those playground instructions to "take turns and play nice."

2011 PARID Mentorship Program

Mentoring Makes a Difference

PARID is offering its second mentorship program for all members who have passed the NIC, CDI, or EIPA written exam and paid for the corresponding performance exam. This is an excellent opportunity for provisionally registered interpreters. This valuable program provides an opportunity for one-on-one skill development with a certified interpreter as well as written comments on areas for skill development from Stephanie Winslow of ASL Interpreter Connect, LLC. Both of these opportunities provide you with additional confidence and personal attention to your skill development aiding you in the successful completion of your certification process.

While the completion of the mentorship program does not guarantee certification, of the nine protégés who completed the first mentorship training in 2008, seven have achieved their desired certification – EIPA (1), CT (1), and NIC (5).

Mentors and protégés will attend a three-day training session on September 16-18, 2011, at the GIANT Super Foods Community Room in Harrisburg, PA. This required 15-hour training provides the tools to make the mentoring process successful. The program is open to any interpreter working towards the RID NIC, interpreters working to attain RID standards on the EIPA, and Deaf interpreters seeking their CDI. At the end of the three-day training, mentors and protégés will be paired based on the needs and strengths of each participant.

After the initial training in September, protégés will submit a recorded pre-mentorship work sample to Stephanie Winslow. Ms. Winslow will view each sample and outline areas of strength as well as skills to develop during the mentor/protégé sessions. Then, mentors and protégés will work together for a minimum of 8 hours. Once the minimum 8 hours mentoring time is completed, protégés will submit a recorded post-mentorship work sample to Ms. Winslow for evaluation of growth in goal areas.

Mentors will use the information from the report Ms. Winslow provides to assist the protégés in developing a plan of action. Then, the mentor will assist the protégé in following that plan of action and provide feedback during the mentoring sessions. If you have been certified for at least 3 years, take advantage of this opportunity and become a mentor.

Mentors will earn 1.5 CEUs for participating in the initial training. In addition, mentors are eligible to earn CEUs for the actual mentoring through the Independent Study Program. PARID will process these CEUs without cost to mentors.

Protégés will earn 1.5 ACET credits for completing the kickoff training in September. Protégés who are certified members of RID may also earn the Independent Study CEUs; however, PARID will not process independent study ACET credits.

This program was developed by PARID to increase the number of certified interpreters working in Pennsylvania. The cost for each protégé is \$250 and it is an excellent investment for anyone desiring personal, one-on-one skill development to help them achieve their certification.
