Be a Verb: Change Is a Comin', Change Is Here

Tupac (2PAC) Shakur sang "Come on come on / I see no changes / .../ Things'll never be the same," while David Bowie chorused, "Ch-ch-chch-changes / Turn and face the strange." Both artists called to their listeners during times of social change, asking them to think of how time and change, or lack thereof, affect the individual as well as the community. The singer's lyrics express the universal inclination of society's longing for and need of change, even while being unable to keep up with it, or, it being unable to keep the pace with us, its makers. The bottom line is that these lyrics are about the impermanence of the world we live in, and the necessity for us to step up to the challenges of change by taking an active role in the processes that affect us.

In fact, the word change itself has a history of evolution in terms of its meanings and applications. While etymological, Old French beginnings in the 13th Century found it functioning in much the same way as it does today - as a verb, literally meaning to alter something, it has functioned differently and expressed alternative meanings along the way. Its Latin roots, expand upon that generalized meaning, offering that it has a sense of bartering or exchanging. Its Celtic origin, on the other hand, suggests that the word's meaning is tied evolutionary processes - the bending and crooking of some thing to directionally turn it around. When the word functions as a noun, however, one can refer back to another of its O.Fr. origins as a financial reference point; more specifically, one that suggests a sense of a balance being returned when something is paid for.

Bittersweet but true is the undeniable and inescapable fact that nothing is lasting, durable, or sure. For instance, some of us, having paid our dues, are expecting more return on our investment than what we are realizing; yet we do little more than grex about the wrongs and the need for righting them. However, to my knowledge, there is no established date, age, or event that precludes us from having to advocate and lobby for our rights, or remain actively involved in the processes that define our present and shape our future. Simply voting for officials to represent us is not enough. And let me be clear, choosing not to vote is an active, officially determining decision to accept come what may. I would posit that perhaps our inactive actions may in fact, be part of the reason a balancing is eluding us. As professionals standing at the crossroads of change be it demonstrable at a technological, accreditation, legislative, or political level we would do best to recognize our potential kinship to the word change and Be a Verb! Start by adopting a positive attitude about change, and exhibit your willingness to be actively involved in the evolutionary events affecting you. Only then can we ensure that solutions are being created that match our expectations and deliver benefits.

Running throughout the pages of this issue are articles and ads that represent these actively occurring changes

within the professional field of interpreting for the Deaf Hard of Hearing. Whether at the local, the state, or the national level, a new season is upon us. Whether are experiencing unwelcome, bartered, exchanged alterations, or selfrealized bending and crooking out of necessity or desire, our investments will continue to be returned – because that is the nature of change rebalancing is always occurring; and don't forget, PARID is here by your side, for you, about you, and by you - PA's premier sign language interpreting professionals. The implied theme throughout newsletter calls you to decide, to act, to join.

Lastly, consider this historical fact, and its relevance to this theme. As early as 1835, Alexis de Tocqueville, a young Frenchman traveling abroad, concluded that one of the prevailing characteristics of the United States' culture is its passion for creating and joining associations organizations that connect professionals to their peers. I would offer that the benefits of this continuous practice are numerous; beyond the fact that it looks good on a resume, and speaks to your commitment to community, it offers information about or opportunities for ongoing accreditation and licensing, networking with one's peers, and sometimes the building of lifelong friendships. So, come on. Change your present by joining your peers in their endeavors to create a more sustainable, albeit changeable and better future interpreters everywhere.



ANNUAL MEETING Q&A



PARID Member Questions Answered Cindi Brown, CI and CT Immediate Past President

Thank you to all of the PARID members who attended the annual business The meeting meeting! minutes will be posted on the website in July. This year we conducted the business a little bit differently than in the past. Members wrote comments and questions on index cards and submitted them. PARID board then answered the questions as they came in. article provides responses to those same questions for those of you who were unable to attend the meeting.

Can we get an update on Act 57 enforcement, compliance, and successes – Is it working?

Sign The Language Interpreter and Transliterator State Registration Act has been successful. It has provided a clear definition of "qualified interpreter" and recourse for deaf and hard of hearing individuals when an unqualified interpreter provided. ODHH responsible for the enforcement of Act 57. This question has been forwarded to Sharon Behun, ODHH Director. See the next newsletter for more information regarding enforcement.

If there is no District Representative, can a PARID member still use district funds to set up a workshop? What is the process?

Yes, a PARID member can use the district's funds for a workshop if there is no representative in his/her district. Contact any PARID board member and request a copy of the "Funds Approval Form". Complete and submit the form and a detailed budget to the board at president@parid.org. The board will consider the request at the next quarterly meeting.

I thought RID stopped the levels of NIC (i.e. master and advanced), but during the meeting it was announced that several members earned those certifications. Please explain.

Yes, RID did stop awarding the NIC-Master and NIC-Advanced during 2011. Interpreters can only earn the NIC at this point. The NIC Master and Advanced certifications that were announced during the annual meeting were earned prior to date RID stopped awarding them. PARID only business/membership meeting a year so all of the certification announcements during the meeting are from the entire previous year (May - April).

What is the SWAP program and is it open to students?

The SWAP program is a library of workshops on CD and on-line that PARID has purchased from Signs of Development for members to When members use these CDs, PARID gets credit from Signs of Development toward the purchase of more CDs. A list of the workshop CDs in PARID's library is on-line www.parid.org. PARID does not earn money from this program. A deposit is charged to a member to borrow a CD. Once the CD is returned or the on-line version is completed, the money is forwarded to Signs of Development for CEU processing. If a member would like to borrow a CD without earning CEUs, the deposit is returned to the member after the CD is returned. The on-line option for the SWAP program is new The SWAP this year. program is open to all PARID members, including student, supporting, and organizational members. Sign Language Interpreter & Transliterator State Registration Act



OFFICE FOR THE DEAF & HARD OF HEARING

Re: Sign Language Interpreter & Transliterator State Registration Act

Video Remote Interpreting (VRI) & Video Relay Service (VRS) interpreters

The Sign Language Interpreter & Transliterator State Registration Act (Act) is a consumer protection law ensuring quality interpreting/transliterating services between individuals who use sign language for communication and individuals who do not use sign language. The Act applies to all individuals who provide sign language interpreting or transliterating services within this Commonwealth and requires these individuals to register with the Office of Deaf and Hard of Hearing (ODHH). In order to register, individuals must meet specific requirements and pay the required registration fee.

Recently questions have been raised regarding the applicability of the Act to Video Remote Interpreting (VRI) and Video Relay Service (VRS) interpreters. The following information is provided to clarify the applicability of the Act to these types of service providers:

Video Remote Interpreting (VRI)

Interpreters who are providing VRI services to individuals within the commonwealth are required to comply with the provisions of the Act; regardless of whether the service is provided "on demand" or scheduled. Further, the following applies to individuals who provide VRI services:

- Interpreters who reside outside the commonwealth and are nationally certified can provide service on-site or remotely up to 14 times per calendar year. The interpreter is required to complete the exemption form and submit it to ODHH.
- Interpreters who reside outside the commonwealth and provide on-site or remote interpreting services to an individual within the commonwealth more than 14 times per calendar year are required to register with the Office for the Deaf & Hard of Hearing.
- Interpreters who reside in the commonwealth & provide VRI to individuals outside
 of the commonwealth boundaries must adhere to the Act.

Video Relay Service (VRS)

- Interpreters who are working for a VRS provider and who are <u>not</u> working within the boundaries of the commonwealth are not subject to the provisions of the Act.
- However, interpreters working at a VRS provider's call center stationed within the commonwealth are to adhere to the Act.


MOTION CARRIED: ONCE MORE WITH FEELING Brian Smith, NIC, Ed:K-12 Recording Secretary
