



UNDERSTANDING VRI PART 2

Understanding Video Remote Interpreting

This article is Part 2 in a series on VRI.

How much experience should an interpreter have in freelance work prior to working in VRI?

Because the interpreter's visual field is limited in most cases to only seeing the Deaf consumer, VRI interpreters should have a minimum of five years (preferably ten) experience working in face-toface onsite interpreting before considering VRI work. Since the majority of available VRI work today is serving the healthcare industry, being trained and continually seeking professional development in medical terminology, medical/ mental health interpreting and understanding of the healthcare system is also essential. The best way to know what a hospital Emergency Room or Operating Room looks like (and how to interact with staff) is to have interpreted in those places, which provides critical context.

What other type of experience would be helpful in VRI?

Having VRS experience is very helpful prior to working in VRI. Like VRI, VRS also provides the 2-dimensional framework of working remotely interpreting via video through the internet. Since ASL is a 3dimensional language, it must be mediated through the technology which is delivered in a 2dimensional format. In addition, VRS provides similar experience in handling multiple communication events (calls) in rapid succession, along with experience in meeting consumers from around the country, without much context before the interpreted interaction. Those skills built in VRS carryover into VRI.

Does a VI working in VRI need to be good at and comfortable with troubleshooting?

Yes! Since VRI is delivered over the internet using a webcam and computer with specialized software, it is critical that the VI be fully trained on how to use the system and how to troubleshoot not only their own VRI connection, but also need to be able to guide hearing clients through any troubleshooting that needs to be addressed right at the beginning of a session before it can proceed. Troubleshooting needs to be handled quickly, efficiently, professionally, and always with a smile.

Is there work available



in VRI?

Yes. As VRI is still an emerging technology, there are some full-time jobs with more part-time jobs available in the industry. This is expected to grow as more users adapt to utilizing the technology. With the NCIEC's recent research on the number of experienced interpreters expected to retire in the next ten years to well outnumber the number of new interpreters entering the field, the demand for VRI will also continue to grow to meet the needs created by this increasing shortage of qualified interpreters.

Will VRI completely replace face to face onsite interpreting?

No. There will always be consumers and/or situations that are not a good match for VRI services. In those cases, the VI should utilize industry and company best practices, and the Code of Professional Conduct to recommend onsite interpreters.

Those skills built in VRS carryover into VRI

Can CDIs work in VRI?

Yes! While not every VRI company can offer Deaf-Hearing teams on screen, another option is

to have a CDI be the onsite interpreter to team with a VI to provide the DH Team. This can work very effectively. If you have additional questions regarding VRI, please contact me at district8rep@parid.org and I'll be happy to answer them.
