Hello everyone,

Welcome to Fall! I hope you enjoyed summer and are getting back into the swing of things now that fall has arrived. Are you looking for opportunities to earn CEUs? Did you know that PARID has a professional development calendar on our website where you can find local, regional and online professional development opportunities?

On the PARID webpage (http://parid.org) go to the left navigation menu and choose Professional Development, then Workshop calendar (or just use this link): http://www.parid.org/workshops/. You can view the calendar in a number of formats – week, month or agenda and can also print it!

Have you ever considered doing an Independent Study to earn CEUs? There are a myriad of ways to earn CEUs through this method. What's even better? Earning CEUs for free! One way to do this would be to utilize the online information for the UCSD ASL Oncology Interpreter Training Program that is currently available online here: http://deafhealth.ucsd.edu/rid/itp/modules.asp#top. This is a self-paced, study program. You can complete a PINRA through PARID by contacting cmp@parid.org. The modules will be available until June 30, 2015. Both the Independent Study and PINRA options require approval by your CEU sponsor BEFORE starting the program. All details and forms are on the professional development page of PARID's website: www.parid.org. As a PARID member, one of our member benefits is that PARID will process the CEUs for free too!

District 8 continued

PARID will be hosting a workshop at the ODHH Hearing Loss Expo in Harrisburg on November 15, 2014. This will be a two-hour workshop entitled "Personalities at Work". You can earn 0.2 CEUs (pending approval) and check out the Expo.

While still on the topic of CEUs - District 8's next workshop will be held next spring in Philadelphia. The topic will be: "Say What?? Navigating the Language of the Legal System." This will be presented by Cheryl Thomas, staff sign language interpreter for the Arkansas Supreme Court Administrative Office of the Courts, Court Interpreter Services. Cheryl presented at the PARID Conference this spring, and her workshop was excellent. The focus is on legal terminology for interpreters who do not provide legal interpreting. It has been expanded to 6 hours and will also include information on the legal documents interpreters encounter in the medical setting. Cheryl is a dynamic presenter and you won't want to miss it! Details will be provided in the next newsletter.

As you may be aware, PARID has a significant need for volunteer involvement. One place you can be involved that doesn't require a large commitment of time is on committees. I am the Board liaison to the Public Policy committee – and sadly I must report that there are no volunteers for this committee. You may think that since we already have Acts 57, 124 & 175 on the books that we might not need a public policy committee. However laws are living documents, and can be changed and new laws that affect our profession can be proposed at any time. ODHH Director Sharon Behun reports currently the legislature is considering telecommunications legislation that could affect the provision of VRS services in Pennsylvania. You do not need to be a member of District 8 to apply to be a member of the Public Policy Committee! PARID members from any district are eligible and just need to submit a letter indicating their interest and qualifications to serve, along with a copy of a recent resume.

Importance of Interpreter Self Care

I am still learning the process of how PARID works and what my role will look like. In the meantime, since I am brand new, I thought I would take a moment to talk about something close to my heart. Perhaps then I will be less of a stranger to you.

First and foremost, let me confess, I am a girl of many passions (and many words...obviously)! You may often hear me say, "one of my passions is..." If I only had a dollar for every time I said that... But it's true! As we get to know each other, I'm sure you will hear about them all. Today, though, I want to focus on my passion for caring for interpreters.

In my former life, I worked in the field of Psychology. That training has had a large influence on me as I developed in my chosen career of interpreting. As I spent some years comparing the two fields, it became clear to me that interpreters need more support. Secondary/vicarious trauma is a real thing for interpreters, but we are often unaware of how it impacts us. In our daily work, we witness the sighs of a million heartaches. We are privy to pain that much of the general population can't begin to comprehend. And on top of that, we don't just witness it, we participate in it vicariously. Don't sell yourself short, dear interpreter. You are a courageous person! You provide hope and communication where none exists! You are a treasured part of someone's very existence. What you do every day has a greater purpose and meaning. Our work is often full of joy. It is also, at times, a heavy burden that we bear.

You know all of this already. You live it every day. I just wanted to take this opportunity to applaud you!! And then remind you...take care of yourself! This is where I see so many parallels with those who work as counselors. We can learn from their framework for self-care. Know your limits. Seek out trusted colleagues to support you when you have had a difficult experience. Join a local or online supervision group. Remember to incorporate a rhythm of rest into your schedule. Hug your kid (or your dog). Read a book for fun. Enjoy some nature. Walk a prayer labyrinth. Attend workshops and seminars that teach you how to create a self-care plan so you can continue to do this much-valued and needed work. Breathe! You are brilliant in your care for the Deaf community...be equally caring of yourself!

Do you work in the K-12 setting? Do you know what resources are available for students and professionals working with Deaf and Hard of Hearing students in Pennsylvania?

2014-15 PSSA and Keystone Video Sign Language Accommodation

The Video Sign Language online version is now available for the Math and Science assessments. Students need to be identified as eligible for the sign language presentation accommodation by the IEP team, with documentation on the IEP and/or Communication Plan, or 504 Plan. Students must use a sign language accommodation during instructional periods and assessments; it should not be used solely during PSSA or Keystone assessments. In order to access the VSL version, students must first be established in the DRC eDirect Test Setup system, with the corresponding VSL accommodation. Utilization of the VSL accommodation does not replace students' onsite educational interpreters during the assessment, as he/she is required to be there to provide access for questions and/or concerns. Further discussion of this accommodation is available on the PDE website. For additional questions, please contact your PaTTAN consultant.
