beginning of April. The results of the election will be announced through email and at the annual meeting.

The PARID board has been working to revise the Policy and Procedure Manual (PPM). This PPM has been under development for several years. The draft is in the final stages. It should be completed and ready for final approval in the next few months. The board's goal with this PPM is that it will be a thorough document and include all of the information necessary for a new board member to step in and carry out his/her duties by following the manual.

PARID has ordered a new display banner for use at PARID events and exhibits. Thank you to the public relations committee for designing this banner. It should be ready to unveil at the conference.

PARID will be sponsoring a seminar

at the PSAD conference in July. At last year's PSAD Conference in Pittsburgh, PARID sponsored an ethics discussion lead by Ben Hall. This discussion was the first of its kind in Pennsylvania. Both Deaf community members and interpreters attended. We learned a lot from each other about the different perspectives that we have. This year PSAD has invited PARID to sponsor another seminar at the PSAD conference. The PARID board is planning to hire Ben Hall to lead another discussion of ethics more specific to the medical setting. Register for the PSAD conference to attend this seminar. The seminar will be on Saturday, July 19, 2014 at the Eisenhower Hotel in Gettysburg. Registration information and the conference schedule are available on the PSAD website at www.psadweb.org.

PARID is approved by the RID CMP to sponsor continuing education activities. Continuing education activities fall into 4 categories: sponsored workshops, PINRAs, independent studies, and academic coursework. To provide this service to the members, we need volunteers to coordinate the paperwork. In order

to not overwhelm our volunteers, the PARID board has divided the CMP coordinating responsibilities into 2 positions: a CMP coordinator for sponsored workshops and PINRAs, and a CMP coordinator for independent studies and academic coursework. In February, the board appointed Lauren Pastore to the position of CMP coordinator for the sponsored workshops and PINRAS, replacing Stephanie Ellison who was the interim CMP coordinator. Heidi Hartely who has processed the independent studies and academic coursework for us will be resigning after 7 years of service. Therefore, we now have the position of CMP coordinator for independent studies and academic coursework to fill. The position description is posted on the PARID website at www.parid.org. Our new Wild Apricot membership database is working well. It allows us to easily send emails to the entire membership or to a specific district. There are 3 different kinds of messages that are sent: workflow, event announcements, and manually sent. You cannot opt out of receiving the workflow emails. These are membership renewal reminders, event registration confirmations, etc. Event announcement emails are pre-set by an event coordinator to automatically be sent as reminders to people who have not yet registered for a PARID event (district seminar or conference). You can select to unsubscribe from these. The manually sent emails are emails specifically initiated by board members and

include information about PARID business. These emails include the electronic newsletter, voting ballots, important updates from PARID and RID, and information regarding interpreting legislation and regulations in Pennsylvania. You can unsubscribe from receiving manually sent emails. Please note, that the PARID board is committed to using discretion when sending emails so as to not overwhelm your inbox. The default setting in Wild Apricot is to receive all emails. If you did not make any changes, you are set to receive all messages.
