District 2 Representative Report Danielle Filip NIC Advanced

During my almost 2 years on the PARID board, the conversation surrounding what it means to be a member of PARID has surfaced time and time again. I have had this conversation with local members - asking them what membership in PARID means to them, with fellow board members - trying to define the benefits of membership for our public relations materials, with non-members - asking them why they aren't a members of PARID

and with folks outside of PARID - asking what membership to professional organizations in general means to them. In all of this, I have gathered that members of organizations, such as PARID, feel disconnected from the larger organization. So, what does it mean to be a member of something? Merriam-Webster defnes the term member as being "a part of a whole" with "ingredient" being a synonym for member. Think about that, you cannot bake a cake with an ingredient missing, right? So how can PARID be a whole, productive organization meeting its mission "to provide state and local forums and an organizational structure for the continued growth and development of the profession of interpretation and transliteration of American Sign Language and English" without all of us doing our part and bringing our own unique favor?

As a District Representative I am tasked with hosting meetings in the district, at the most recent meeting 3 members - out of 65 in the district - came, in addition to the 3 board members present. While we had great conversation as a group and then learned together about our work interpreting ASL to English guided by an archived presentation by Stephanie Feyne, it didn't feel whole. We were quite obviously missing the vast majority of District

2. The recipe analogy strikes me as one which is fitting here, again. As District Representative, the "chef" in this situation, maybe I think District 2 is supposed to be a cake when you all as interpreters are actually ingredients destined to be a casserole. The only way to know this is to come together. Like setting all the ingredients on the counter, to see what unique favors we all have to bring.

Perhaps I'm beating a dead horse at this point, but I often watch the show Chopped and they take the most random ingredients out of their mystery baskets and make fabulous (most of the time) dishes from them. In most cases, each of the chefs take their own spin on how the ingredients should be used and end up composing different dishes PARID is the same; each district is its own basket and while all comprised of interpreters each district will operate in a unique way. It is the District Rep's job to bring the interpreters together in a cohesive way - to be the chef as I said before. But, we must open our baskets and fnd you our members, an assortment of fresh ingredients, ready to blend into a masterpiece of a menu.

My time as board member is coming to a close and I will miss the involvement with PARID but need to use my time to focus on the work I'm doing with other areas of the interpreting field. I intend to remain involved with PARID and hopefully with the Board again in the future. As most of you know, the membership year will come to an end on June 30, 2015. Depending on your preference, paper or electronic renewal notices have been sent out to those memberships that will expire. A discount is offered for renewals and new memberships

postmarked between June 1, 2015 – June 30, 2015. With that said, there are a few important comments I'd like to make regarding your membership renewal:

- If you've recently renewed your membership or registered to become a member, you have been registered for the 2014-2015 membership year, NOT the 2015-2016 membership year. Memberships received before June 1, 2015 will not be applied to the new membership year.
- Please pay special attention to your district number! Whether you renew/join on-line or via our paper
 membership form, there is a district map available on the form, as well as PARID's website for your
 reference. An error in your district number directly relates to the amount of money each district
 receives.
- If you are using our paper membership form, please pay special attention to the dates by which your payment needs to be postmarked. ANY payment received AFTER the postmarked date (found on the mailed envelope, not your check) of June 30, 2015, will not be able to be processed until the remaining balance of your membership dues is received. You will received an email or phone call if this should occur.
- You can sign up for 1, 2 or 3 year memberships, so if you did not receive an email or paper renewal form in the mail, your membership is either active for 1 or 2 more years or was not renewed previously.

If you have questions regarding your membership status, you can always contact the Corresponding Secretary at membership@parid.org or login to your account at www.parid.org. There is an option to reset your password if needed. Also, as previously stated, PARID has discontinued issuing membership cards to its members. If you feel strongly about having a membership card you can contact the Corresponding Secretary at the same e-mail address above. Memberships cards will only be issued in batches three times per year. Please email for details.


